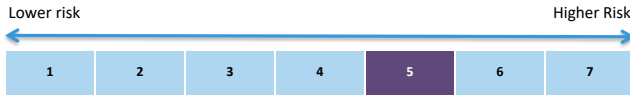

### Investment Universe and Investment Objectives

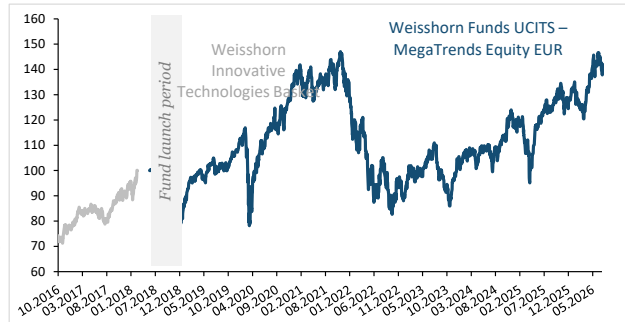

The investment objective of the Sub-Fund is to seek long-term capital growth by investing in a portfolio of worldwide equities. The investment selection will be based on a combination of “Top-Down” approach and “Bottom-Up stock picking” selection process. The management team will focus on global megatrends reshaping our world: Technological innovations, Evolving population dynamics, Resource utilization. To achieve its objective, the Sub-Fund will mainly invest in equities and equity related securities (such as depositary receipts) of companies worldwide.



The Weisshorn MegaTrends Equity fund is a long term equity investment vehicle suitable for long term investors (5-year minimum holding horizon). 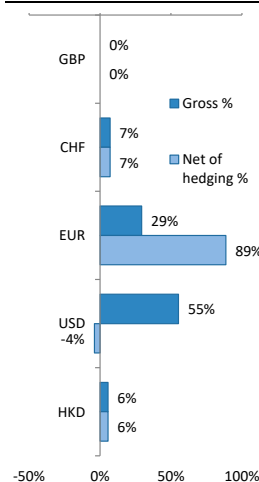

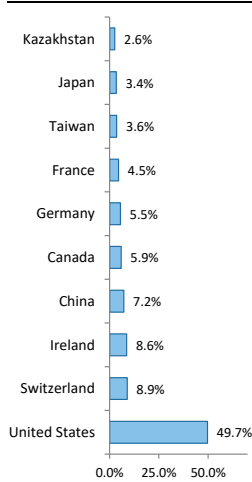

### Currency Exposure



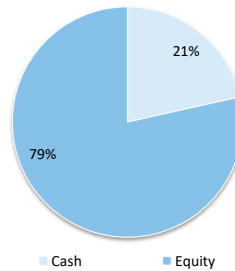

### Asset breakdown



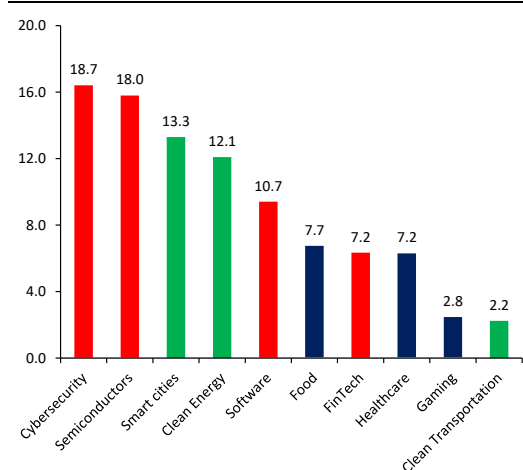

In July, global financial markets navigated a second consecutive month of geopolitical stress, as the Middle East conflict escalated sharply again toward month-end. Brent crude surged past \$100 a barrel for the first time since May, briefly touching levels near \$101 amid attacks on tankers in the Red Sea and threats to strike Iranian infrastructure, before retracing to close the month closer to the mid-\$90s. Equities again proved more resilient than the headlines suggested. In this context, the MSCI World increased by +0.53%, the S&P 500 decreased by -0.06%, while the STOXX 600 rose +1.27% and the SPI rose +0.73%, over the period. Gold rose +0.95% and Brent rose +23.46%. The Bund10Y made -0.71% and the US10Y +6.03%. Our fund delivered a performance of -3.08% over the period bringing the year to date to +11.08%.

July was defined a lot by a wall of central bank decisions, all landing within days of each other. The ECB kept its three key rates unchanged on July 23rd, holding the deposit rate at 2.25%, as energy price volatility argued for a pause rather than a resumption of hikes, consistent with the "wait and see" stance signaled by Governing Council sources heading into the meeting. The Fed, under new Chair Kevin Warsh, left rates unchanged at 3.5%-3.75% on July 29th in a split 9-3 vote, with Warsh offering little forward guidance on the mix of risks or the path of policy, leaving bond markets to parse a notably hawkish undertone against a backdrop of sticky inflation and a still-resilient labour market. The Bank of England also kept the Bank Rate at 3.75% on July 30th despite the spike in oil and gas prices, reflecting the MPC's judgement that the energy shock has not yet meaningfully fed through to core inflation or wage growth. The Bank of Japan, having already hiked 25bps to 1.0% in June, also maintained rates steady at 1% at its July 31 meeting, while retaining hawkish language on inflation overshoot risk given the weak yen and rising import costs from the energy shock, with markets now pricing a further hike to 1.25% as soon as October or December.

Fixed income and credit markets remained caught between the same conflicting forces as in June, this time amplified: a fresh oil shock pushing headline inflation expectations higher, against four major central banks collectively choosing to stay on hold rather than react. Long-end yields stayed elevated and the curve remained flat to inverted in places, while credit spreads stayed contained, suggesting investors continued to treat the energy spike as a geopolitical shock rather than a demand-driven inflation problem requiring an aggressive policy response. CDS and bond spreads increased strongly for Hypersclares during the month, reflecting investor concern that the funding of the AI capex cycle is becoming a real balance-sheet issue.

At the micro level, earnings season dominated the narrative, with the AI capex cycle and its financing needs remaining the central debate as Hyperscalers continued to tap debt markets and increase capex projections, even as investors grew more discerning on valuation dispersion within the theme. European equities extended their outperformance, again helped by financials and industrials, while the broader growth and financial conditions backdrop stayed little changed from June. Japan remained a standout on continued semiconductor exposure, though the BoJ's hawkish holding pattern and a persistently weak yen kept the narrative of Japan as a growing source of global duration risk firmly intact. China's picture stayed similarly mixed to June, with uneven growth and fragile consumer confidence continuing to weigh against incremental policy support. Korea added another volatile layer to the global picture as the KOSPI saw a violent July drawdown driven by AI skepticism and extreme concentration in semiconductors.

At the Portfolio level, our strongest contributors were again the Software and Fintech, which delivered respective returns of +10.58% and +9.94%. For Software, we saw some excessive fears decreasing regarding the disruption of IA in the sector. Investors now seem to be looking again at the sector and being selective on future winners. On the other side, Semiconductors and Clean Energy were our weakest contributors, declining by -19.63% and -12.98%, respectively. Semiconductors saw some profit taking after a very strong and historical first half of the year.

At the stock level, Microsoft and SBI Holdings were the top contributors, each advancing by approximately +24.58% and +17.47%. Microsoft stock surged in late July due to a record-breaking earnings report, stronger-than-expected Azure cloud growth, and reassuring AI monetization update. Conversely, Lam Research and AMD were the main detractors, posting declines of -32.38% and -18.03%, respectively. The correction in Lam and MAD was due to a broad de-risking across semiconductor and AI-linked hardware stocks. For Lam, reports that a state-backed Chinese firm started mass-producing homegrown immersion DUV lithography machines brought competition fears.

During the month, we took some profits in Palo Alto after +475% since the first time we bought it, as the company had a big run up into good results and as we still have a strong weight in the cybersecurity theme.
